SECTION A: ENVIRONMENTAL (NATIONAL)

Disaster Management Act 57 of 2002 ("DMA"):

1. Notice outlines the classification of a provincial disaster due to the life safety impact of sinkholes in the Merafong City Local Municipality, Gauteng. The National Disaster Management Centre has assessed updated reports and determined that the sinkholes pose a significant risk to life, property, infrastructure, and basic services. As a result, the disaster is classified under Section 23(1)(b) of the Disaster Management Act, 2002. Published in GG 53108 NN 6480 dated 4 August 2025.

Climate Change Act 22 of 2024 ("CCA"):

2. Notice invites nominations for Commissioners to the Presidential Climate Commission (PCC), a statutory advisory body tasked with guiding South Africa's climate change response and just transition to a low-emissions, climate-resilient economy. Nominees must be South African citizens with relevant qualifications and expertise in socio-economic, environmental, and sustainability fields, and should represent diverse stakeholder groups including government, labour, civil society, traditional leaders, SALGA, and business. Members of the public are invited to submit nominations by no later than 29 August 2025. Published in GG 53123 NN 276 dated 6 August 2025.

Electricity Regulation Act 4 of 2006 ("ERA"):

3. Notice outlines the determination of 400 MW new generation capacity, comprising 100 MW solar photovoltaic and 300 MW natural gas, to be procured by eThekwini Metropolitan Municipality through a fair and competitive tendering process, in terms of section 34(1) of the Electricity Regulation Act 4 of 2006. Published in GG 53138 NN 6494 dated 8 August 2025.

National Environmental Management Act 107 of 1998 ("NEMA"):

4. Notice sets out the Environmental Authorisation and Water Use Licence application process for the proposed construction of a 49 km 400 kV loop-in loop-out powerline and expansion of the Paulputs substation by the National Transmission Company South Africa SOC Ltd, in accordance with the Environmental Impact Assessment Regulations under the National Environmental Management Act 107 of 1998. Published in GG 53155 NN 3432 dated 15 August 2025.

National Environmental Management: Integrated Coastal Management Act 24 of 2008 ("NEM:ICMA"):

5. Notice establishes the Regulations for the Environmental Management of Offshore Ship-to-Ship Transfer, issued under section 83(1) of the National Environmental Management: Integrated Coastal Management Act 24 of 2008. These regulations set out prohibitions, wildlife protection measures, spill mitigation requirements, training obligations, and authorisation procedures for ship-to-ship fuel and cargo transfers at sea. Published in GG 53242 NN 6551 dated 28 August 2025.

National Environmental Management: Air Quality Act 39 of 2004 ("NEM:AQA"):

- 6. Notice establishes the amendment and expansion of the boundaries of the declared Waterberg-Bojanala Priority Area to include Kgetlengrivier Local Municipality, Moretele Local Municipality, and the City of Tshwane Metropolitan Municipality, in terms of section 18(1) of the National Environmental Management: Air Quality Act 39 of 2004. Published in GG 53241 NN 6547 dated 29 August 2025.
- 7. Notice proposes amendments to the list of activities and associated minimum emission standards identified under section 21 of the National Environmental Management: Air Quality Act 39 of 2004, to improve regulatory clarity, licensing, and pollution prevention. Published in GG 53241 NN 6548 dated 29 August 2025.

National Environmental Management: Waste Act 59 of 2008 ("NEM:WA"):

8. Notice establishes the National Policy for the Management of Waste Electrical and Electronic Equipment (WEEE), providing a comprehensive framework for environmentally sound management, stakeholder roles, and extended producer responsibility. Published in GG 53243 NN 6554 dated 29 August 2025.

9. Notice publishes the Strategy for Reducing Food Losses and Waste, developed under the National Environmental Management: Waste Act, 2008, to guide national efforts in minimising food waste, promoting circular economy practices, and improving food security. Published in GG NN 6556 dated 29 August 2025.

Marine Living Resources Act 18 of 1998 ("MLRA"):

- 10. Notice establishes the Regulations for the Entry of Foreign Fishing Vessels into South African Waters, aimed at preventing illegal, unreported, and unregulated (IUU) fishing and regulating port access, gear stowage, and vessel tracking. Published in GG 53208 NN 6524 dated 22 August 2025.
- 11. Notice establishes the Consultative Advisory Forum for Marine Living Resources (CAFMLR) under section 5 of the Marine Living Resources Act 18 of 1998 and invites nominations for qualified members to serve on the forum. Members of the public are invited to submit nominations within 30 days from the publication of this notice. Published in GG 53210 NN 6533 dated 22 August 2025.

Plant Breeders' Rights Act 12 of 2018 ("PBRA"):

12. Notice establishes the Regulations made in terms of the Plant Improvement Act 11 of 2018, governing the registration, certification, sale, import, and export of plants and propagating material, including provisions for Cannabis sativa L. (hemp). Published in GG 53241 NN 6546 dated 29 August 2025.

National Nuclear Regulator Act 47 of 1999 ("NNRA"):

13. Notice corrects NN 6512 published in GG 53155 of 15 August 2025 by including the previously omitted Annexure A, which sets out the authorisation fees for nuclear activities for the 2025/26 financial year under the National Nuclear Regulator Act 47 of 1999. Published in GG 53243 NN 6557 dated 29 August 2025.

National Water Act 36 of 1998 ("NWA"):

14. Notice establishes the Reserve Determination for water resources of the Berg catchment in the Berg-Olifants Water Management Area, in terms of section 16(1) and (2) of the National Water Act 36 of 1998. Published in GG 53243 NN 6559 dated 29 August 2025.

SECTION B: SAFETY, HEALTH & OTHER (NATIONAL)

Administrative Adjudication of Road Traffic Offences Amendment Act 4 of 2019 ("AARTO"):

15. Notice stipulates the phased commencement of the Administrative Adjudication of Road Traffic Offences Amendment Act 4 of 2019, specifying implementation dates for different municipalities. Sections 17–35 will come into effect on 1 December 2025 (municipalities listed in Annexure A) and 1 April 2026 (municipalities listed in Annexure B), while section 2(g) will commence on 1 September 2026. Published in GG 53099 NN 272 dated 1 August 2025.

Administrative Adjudication of Road Traffic Offences Act 46 of 1998 ("AARTO"):

16. Notice outlines the commencement of the Administrative Adjudication of Road Traffic Offences Act 46 of 1998, with sections 17 to 20, 23, and 29 to 35 coming into operation on 1 December 2025 in municipalities listed in Annexure A, on 1 April 2026 in municipalities listed in Annexure B, and sections 24 to 28 coming into operation nationwide on 1 September 2026. Published in GG No 53099 NN 274 dated 1 August 2025.

SECTION C: DRAFT SAFETY, HEALTH AND ENVIRONMENTAL FOR COMMENT (DRAFT NATIONAL LEGISLATION AND REGULATIONS)

Climate Change Act 22 of 2024 ("CCA"):

17. Notice outlines the publication of draft National Greenhouse Gas Carbon Budget and Mitigation Plan Regulations under the Climate Change Act 22 of 2024. These draft regulations establish mandatory requirements for carbon budget allocations and mitigation plans, including the declaration of greenhouse gases and activities, compliance mechanisms, reporting obligations, and enforcement provisions. Members of the public are invited to submit comments within 60 days from the publication of this notice. Published GG 53103 NN 6476 dated 1 August 2025.

18. Notice outlines the publication of draft Technical Guidelines for the National Greenhouse Gas Carbon Budget and Mitigation Plan Regulations under the Climate Change Act 22 of 2024. These guidelines detail the structure, methodology, and compliance processes for carbon budgeting and mitigation planning, including data collection, emissions reporting, verification, progress tracking, and enforcement. Members of the public are invited to submit comments within 60 days from the publication of this notice. Published in GG 53103 NN 6477 dated 1 August 2025.

National Environmental Management Act 107 of 1998 ("NEMA"):

- 19. Notice outlines PetroSA's Regulation 34 compliance audits for offshore exploration Blocks 9 and 11A (south coast) and Blocks 2C and 3A/4A (west coast), conducted by Environmental Impact Management Services (EIMS). Members of the public are invited to submit comments on or before 1 September 2025. Interested and Affected Parties (I&APs) are encouraged to register with EIMS and provide feedback, which will be submitted to the Department of Mineral and Petroleum Resources for consideration. Published in GG 53131 NN 3422 dated 8 August 2025.
- 20. Notice establishes the draft regulations to prohibit the use, production, distribution, sale, import, and export of plastic microbeads and products containing microbeads, in terms of the National Environmental Management Act 107 1998. Members of the public are invited to submit comments within 30 days from the publication of this notice. Published in GG 53137 NN 6493 dated 8 August 2025.

National Environmental Management: Integrated Coastal Management Act 24 of 2008:

21. Notice invites public comment on the revised draft Orange River Mouth Estuarine Management Plan (EMP), aimed at improving ecological health and coordinating stakeholder actions under the Integrated Coastal Management Act, 2008. Members of the public are invited to submit written representations or objections on the revised draft EMP within 30 days after the publication of this notice. Published in GG 53243 NN 6555 dated 29 August 2025.

Basic Conditions of Employment Act 75 of 1997 ("BCEA"):

22. Notice outlines the intention to withdraw the variation notice issued under section 50(9)(a) of the Basic Conditions of Employment Act 75 of 1997, which excluded the application of section 34A regarding contributions to benefit funds covered by the Pension Fund Act, 1956. Members of the public are invited to submit comments within 30 days from the publication of this notice. Published in GG 53181 NN 6518 dated 18 August 2025.

Occupational Health and Safety Act 85 of 1993 ("OHSA"):

23. Notice invites public comments on the Draft General Machinery Regulations, 2025, issued under the Occupational Health and Safety Act 85 of 1993, covering supervision, safeguarding, operation, and maintenance of machinery to ensure workplace safety. Members of the public are invited to submit comments within 90 days from the publication of this notice. Published in GG 53210 NN 6532 dated 22 August 2025.

Civil Aviation Act 13 of 2009 ("CAA"):

24. Notice proposes amendments to the Civil Aviation Regulations, 2011, and associated Technical Standards under the Civil Aviation Act, 2009, covering areas such as aircraft maintenance, aviation accidents, remotely piloted aircraft systems, aerodromes, fees, and vision systems. Members of the public are invited to submit comments on or before 28 September 2025. Published in Government Gazette No. 53243, Notice No. 6558, dated 29 August 2025.

Plant Improvement Act 11 of 2018 ("PIA"):

25. Notice outlines the regulations made under the Plant Improvement Act 11 of 2018, establishing a comprehensive legal framework for the registration, certification, sale, import, export, and handling of plants and propagating material, including provisions for hemp cultivation and seed regulation. The regulations aim to ensure varietal integrity, phytosanitary standards, and compliance with national and international norms. Published in GG 53241 NN 6546 dated 29 August 2025.

SECTION D: SAFETY, HEALTH AND ENVIRONMENTAL (PROVINCIAL LEGISLATION AND MUNICIPAL BY-LAWS)

Free State Province

- 26. Notice outlines transitional measures for the implementation of the Municipal Demarcation Board's redetermination to exclude Fauresmith, Jagersfontein, Reddersburg, and Edenburg from the Kopanong Local Municipality and establish a new municipality. It details the transfer of assets, staff, and administrative functions, and sets out the roles of newly formed Political and Technical Steering Committees and a Transformation Manager to oversee the process. Published in PG 9124 NN 64 dated 29 August 2025.
- 27. Notice outlines the adoption and publication of the Spatial Development Framework (SDF) 2025–2030 for the Mantsopa Local Municipality, replacing the previous framework and detailing updated spatial policies, strategies, implementation mechanisms, and capital expenditure plans in accordance with SPLUMA. The framework was subject to a 60-day public participation process and formally adopted by Council Resolution. Published in PG 115 NN 51 dated 15 August 2025.

Gauteng Province

28. Notice outlines amendments to the Gauteng Provincial Road Traffic Regulations, 2001, under the Gauteng Provincial Road Traffic Act, 1997, including updated motor vehicle registration and licence fees across various vehicle categories. These changes aim to reflect current economic conditions and improve regulatory clarity. Published in PG 292 NN 635 dated 12 August 2025.

KwaZulu-Natal Province

- 29. Notice outlines the establishment of the Fire Safety By-Law for the uMgungundlovu District Municipality, providing a comprehensive legal framework for fire prevention, emergency response, hazardous substances management, and public safety. It includes provisions for the creation of a fire brigade service, regulation of flammable substances, fire control zones, and enforcement mechanisms. Published in PG 2836 NN 654 dated 7 August 2025.
- 30. Notice outlines the approval and publication of the Newcastle Municipality Building By-Laws, which establish comprehensive regulations for building construction, encroachments, objectionable buildings, and enforcement procedures. These By-Laws aim to ensure safety, structural integrity, and aesthetic standards in the built environment, while providing mechanisms for compliance, penalties, and appeals. Published in PG 2839 NN 657 dated 14 August 2025.

Limpopo Province

- 31. Notice outlines the declaration of the Greater Mooketsi Nature Reserve in Limpopo Province under the National Environmental Management: Protected Areas Act 57 of 2003, following public consultation, publication of intent, and agreements with landowners. The reserve comprises 4,933.0146 hectares across multiple farms and aims to enhance biodiversity conservation and protected area management. Published in PG 3724 NN 1156 dated 15 August 2025.
- 32. Notice outlines the establishment of the Mopani District Municipality Municipal Health Services By-Law, providing a comprehensive legal framework for environmental health governance, regulation, enforcement, and public health protection across various premises including schools, health facilities, accommodation establishments, and public spaces. The By-Law details requirements for health certificates, sanitation, waste management, food safety, animal keeping, and enforcement mechanisms. Published in PG 3729 NN 1176 dated 29 August 2025.

Mpumalanga Province:

33. Notice sets out the open and closed hunting seasons for ordinary game species in the Mpumalanga Province for the 2026 - 2027 period, in terms of section 7(1)(a) of the Mpumalanga Nature Conservation Act 10 of 1998. Published in GG 53210 NN 3440 dated 22 August 2025.

North West

- 34. Notice outlines the declaration of eight portions of the farm Boekenhoutfontein No. 260 JQ in the North West Province as the Kedar Nature Reserve under the National Environmental Management: Protected Areas Act 57 of 2003. Ripley's Resources and Trading (Pty) Ltd is appointed as the management authority. The reserve spans a total of 366.6504 hectares. Published in PG 8886 NN 1159 dated 12 August 2025.
- 35. Notice outlines the declaration of 28 portions of land in the North West Province as the Khamab Kalahari Private Nature Reserve under the National Environmental Management: Protected Areas Act 57 of 2003. The reserve spans a total of 95,456.2992 hectares and Khamab Kalahari (Pty) Ltd is appointed as the management authority. Published in PG 8886 NN 1160 dated 12 August 2025.
- 36. Notice outlines the declaration of Portions of the farms Wolwehoek No. 932 KP and Sebele No. 931 KP in the North West Province as the Melorane Nature Reserve under the National Environmental Management: Protected Areas Act 57 of 2003. Loxvita (Pty) Ltd is appointed as the management authority, and the reserve spans a total of 6,832.5268 hectares. Published in PG 8886 NN 1161 dated 12 August 2025.
- 37. Notice outlines the declaration of 24 portions of the farm Wilgeboomspruit No. 262 JP in the North West Province as the Wilgekrans Nature Reserve under the National Environmental Management: Protected Areas Act 57 of 2003. BIDCO Property Development CC is the landowner, and Mr. Willem Bester is appointed as the management authority. The reserve spans a total of 2,847.8597 hectares. Published in PG 8886 NN 1162 dated 12 August 2025.
- 38. Notice outlines the declaration of 31 portions of land in the North West Province—primarily on the farms Geluksdal 112 HP, Klipspruit 89 HP, Voetpaddrift 98 HP, and Wolvespruit 93 HP—as the Wolwespruit Nature Reserve under the National Environmental Management: Protected Areas Act 57 of 2003. The North West Parks and Tourism Board is appointed as the management authority, and the reserve spans a total of 1,757.4578 hectares. Published in PG 8886 NN 1163 dated 12 August 2025.
- 39. Notice outlines the promulgation of the Moretele Local Municipality Unlawful Land Occupation By-Law, 2024, which establishes a legal framework to prevent, manage, and regulate unlawful land occupation within the municipality's jurisdiction. It defines procedures for identifying and responding to informal settlements, appoints authorised officials, and sets out offences and penalties for contraventions. The bylaw aligns with national legislation including PIE, ESTA, SPLUMA, and others. Published in PG 8888 NN 714 dated 19 August 2025.
- 40. Notice outlines the adoption and publication of the Draft Waste Management By-Law for the Moretele Local Municipality, aimed at regulating the storage, collection, transportation, recycling, treatment, and disposal of waste in a manner that promotes environmental sustainability, public health, and service efficiency. It establishes legal and administrative frameworks, defines responsibilities, and sets penalties for non-compliance. Published in PG 8888 NN 715 dated 19 August 2025.
- 41. Notice outlines the Development Plan/Integrated Implementation Programme for the Ditsobotla Priority Human Settlement Housing Development Area (PHSHDA), prepared by the Ditsobotla Local Municipality in partnership with the Housing Development Agency and the North West Department of Human Settlement. The plan aims to address housing and spatial development challenges by promoting sustainable communities, upgrading informal settlements, and improving access to infrastructure. Published in PG 8890 NN 1175 dated 26 August 2025.
- 42. Notice outlines the Development Plan/Integrated Implementation Programme for the JB Marks Priority Human Settlement Housing Development Area (PHSHDA), prepared by the JB Marks Local Municipality in collaboration with the Housing Development Agency and the North-West Department of Human Settlement. The plan targets the Ventersdorp area to address housing shortages, urbanisation, and service delivery challenges through integrated development and spatial transformation. Published in GG 8890 NN 1177 dated 26 August 2025.
- 43. Notice outlines the Development Plan/Integrated Implementation Programme for the Mahikeng Central Business District Priority Human Settlement Housing Development Area (PHSHDA), prepared by the

Mahikeng Local Municipality in partnership with the Housing Development Agency and the North West Department of Human Settlement. The plan aims to address housing backlogs, upgrade informal settlements, and promote integrated urban development in Mahikeng, a strategic regional hub. Published in GG 8890 NN 1178 dated 26 August 2025.

44. Notice outlines the Development Plan/Integrated Implementation Programme for the Naledi Local Municipality Priority Human Settlement Housing Development Area (PHSHDA), focused on spatial transformation and sustainable community development in Vryburg, North West Province. The plan aims to address infrastructure backlogs and service delivery challenges while promoting integrated urban renewal and housing delivery. Published in PG 8890 NN 1180 dated 26 August 2025.

Western Cape Province

- 45. Notice establishes the Bergrivier Municipality Air Quality By-law, which provides a legal framework for managing and controlling air pollution within the municipality's jurisdiction, including provisions on emissions, monitoring, licensing, enforcement, and public health protection. Published in PG 9110 dated 1 August 2025.
- 46. Notice establishes the Bergrivier Municipality Coastal Access Land By-Law, which provides procedures for designating, regulating, and managing coastal access land to ensure public access to coastal public property, enforce rules, and protect the coastal environment. Published in PG 9111 dated 1 August 2025.
- 47. Notice outlines the approval of a subdivision and consent use application for renewable energy facilities on Farm 400, Sunnyside, Beaufort West, to enable the development of the Sunnyside Solar PV Facility. The application was approved under the Beaufort West Municipal Land Use Planning By-Law, subject to conditions including site development plans, environmental compliance, and service agreements. Published in PG 9120 NN 602 dated 15 August 2025.
- 48. Notice outlines the formal protection of a portion of Farm 40, Boebezaks Kraal, "Kasteelberg", Vredenburg, Cape Town as a Provincial Heritage Site under Section 27 of the National Heritage Resources Act (Act No. 25 of 1999). The site is recognized for its archaeological significance as the most important ancestral Khoekhoen herder site complex in South Africa, with evidence of early pastoralism, cultural practices, and trade history. Published in PG 9124 dated 22 August 2025.

Gauteng Province

- 49. Notice proposes the Draft Cemetery and Crematorium By-laws for the City of Ekurhuleni, in terms of section 7 of the Gauteng Rationalisation of Local Government Affairs Act 10 of 1998, read with sections 11 and 12 of the Local Government Municipal Systems Act 32 of 2000. Members of the public are invited to submit comments on or before 5 September 2025. Published in PG 287 NN 615 dated 6 August 2025.
- 50. Notice invites public comments on the establishment of the Environmental Management By-Law for the Midvaal Local Municipality, aimed at creating a legal framework for local environmental governance, regulatory compliance, enforcement, and ecological management. Members of the public are invited to submit comments on or before 8 September 2025. Published in PG 285 NN 911 dated 6 August 2025.
- 51. Notice invites public comments on the review of the Waste Management By-Law for the Midvaal Local Municipality, aimed at aligning with legislative requirements, improving enforcement, and enhancing environmental governance. Amendments include updates to offences, penalties, and repeal clauses. Members of the public are invited to submit comments on or before 8 September 2025. Published in PG 285 NN 912 dated 6 August 2025.
- 52. Notice invites public comments on the draft Cemetery and Crematoria By-Law for the Midvaal Local Municipality, aimed at regulating and managing cemeteries and crematoria in an environmentally sustainable, equitable, and socially beneficial manner. It includes provisions for service delivery,

- enforcement, and penalties for non-compliance. Members of the public are invited to submit comments on or before 8 September 2025. Published in PG 285 NN 915 dated 6 August 2025.
- 53. Notice outlines the proposed review of the City of Ekurhuleni Spatial Planning and Land Use Management By-Law (2019), inviting stakeholder engagement to address legislative updates, implementation gaps, and alignment with national planning frameworks. The review aims to improve regulatory efficiency, promote investment, and ensure compliance. Members of the public are invited to submit comments on or before 9 October 2025. Published in PG 310 NN 625 dated 27 August 2025.
- 54. Notice invites public comments on the Environmental Authorisation and Water Use Licence application by Alleyroads Kidds Beach Land Dev (Pty) Ltd for a proposed integrated township development in Ekurhuleni, Gauteng. The project includes residential, commercial, educational, and recreational facilities over 56.5 hectares, with supporting infrastructure. The application is subject to public participation under Chapter 6 of the EIA Regulations and includes activities listed under NEMA and NWA. Published in PG 309 GN 652 dated 27 August 2025.

North West Province

It introduces new definitions, provisions for protected areas, species management, and enforcement mechanisms. Members of the public are invited to submit comments within 14 days from the publication of this notice. Published in PG 8884 NN 1142 dated 8 August 2025.
- 57. Notice outlines the intention to declare Portion 2 of the farm Bokkraal No. 344 JP in the North West Province as the Drylands Nature Reserve under the National Environmental Management: Protected Areas Act 57 of 2003. The notice also proposes appointing Mr. Jan Abraham Christoffel Dry as the management authority.
